RFID

Registration via RFID cards or smart card readers.

Two-Way Authorization

If the authorization is via RFID, the user can enter a user name and / or password.

Two-Man Rule

In the case of particularly critical applications the confirmation by a second person may be compulsory.

Decentralized user administration

All changes to group and user master data can be made by any PEL Touch Client or desktop PC in the network and are immediately up-to-date on all PEL PCs in the system.

Import from other applications

If required, audit trail files from other applications (for example WinCC Audit Trail) can be imported in CSV format. Advantage: only <u>one</u> interface to <u>one</u> system.
